
INCOME and EXPENDITURE

In 2008-9 The Children's Sunshine Home expenditure was \in 5,370,960 Our fundraising costs were slightly lower than in previous years at \in 144,119

In 2008-9 The Children's Sunshine Home income was €5,110,029

Donations from individuals, companies, groups and trusts remained the most important source of funding for us, accounting for 19% of our income.

Funding from statutory sources increased slightly to 81% of our income, but we will continue to work with HSE to secure more funding in future years.
